More than 220,000 suggestions were received on the draft constitutional law in Uzbekistan, with over 60 percent of them provided directly by young people, indicating their active engagement with the constitutional reform process. The state's guarantee of free general secondary education and primary professional education is another important innovation, which underscores the government's commitment to promoting equal access to education for all citizens. Furthermore, the provision of inclusive education and training in educational institutions for children with special educational needs is a significant norm that emphasizes the government's commitment to promoting diversity and inclusion in the education system. This norm ensures that children with physical, mental, sensory, or mental disabilities are not isolated and have the opportunity to develop and mature as full members of society.

The updated Constitution of Uzbekistan establishes the right of citizens to receive higher education at the expense of the state, based on selection in state educational institutions. This constitutional provision is a significant step towards ensuring that the positive trend of increasing the number of state grants for higher education is sustained, and that grant seats in state higher education institutions are not reduced. In the last five years, the number of state grants for higher education has increased by 75%, and the number of state

grants for women and girls with children from needy families has doubled. Additionally, the practice of allocating state grants for the training of specialists in non-state higher education institutions has been established. Moreover, the Constitution recognizes the state's responsibility to create an environment that fosters the full physical, mental, and cultural development of children.
