- Capitalize coercion, power or danger, incl forging;
- Capitalize kidnapping or duplication ;
- There is abuse power or place weaknesses in which the individual No own other decisions except give up;

• Installments or given advantages or got For get agreement from someone who has order on others, for utilise administration of the person, incl work or administration coercion or intentional, practice slavery or slavery, or objective double For prostitution or in various type connection double sexual including porn.

In Indonesia, understanding deal with the person poured in Regulation Number 21 of 2007 concerning Eradication Crime Deal With People, namely :

Demonstration For register , designate , hold , send , transfer , or get somebody through danger power, use power, kidnapping, fraud, misrepresentation, transaction double, persecution violence or place detention , servitude must or gift installment or profit For get agreement from the person holding it command over another person , whether committed within the country or between countries with objective end For toying or get people taken advantage of ".definition above describe that deal with people can combine all infringing activity _ legal and done with illegal way For look for profit by one party with harm the other party doesn't can take right step .
