When social services are correctly organized, vulnerable citizens will find their place.[1]" Furthermore, the President pays special attention to organizing social services and assistance at the neighborhood level. Recently, systemic and fair evaluations of low-income families have led to some households with regular income being excluded from this category. Additionally, over 2,000 individuals living alone and needing assistance have received support. According to statistics, although the current system of social protection provides 250 services, most people are unaware of these

services. Therefore, a decree was issued on June 1, 2023, to improve the provision of quality social services and assistance to the population, and the National Social Protection Agency was established under the President of Uzbekistan.

The agency develops criteria for identifying vulnerable families and determines the specific type of assistance they require. As a result, individualized social services are provided to each person in need. Moreover, representatives of the "neighborhood seven" visit households to identify issues, assess conditions, and draw a "social portrait" of the household. The underlying goal of this effort is not to reduce expenditures but to direct funds to genuine beneficiaries and integrate them into society.

Uzbekistan's accession to the Convention on the Rights of Persons with Disabilities in 2021 marked a significant step towards ensuring human rights and advancing social justice. Through its membership in this convention, the state aims to protect the rights of persons with disabilities and create opportunities for their full and equal participation in social life. The nation's leader emphasized, "To create a barrier-free environment for persons with disabilities to work and acquire skills, the practice of assessing 'capacity for work' is being abolished. Disability is determined not by illness but by the individual's ability to move independently, communicate, and participate in social life." Furthermore, a system has been implemented to provide referrals for treatment at preventive health centers for citizens with disabilities and those of pension age[2]. These measures certainly promote equality and ensure human rights within society. Such approaches align with the principles of a social state in New Uzbekistan and aim to enhance human well-being.
